1. Hopi Arsenic Mitigation Project (HAMP): After waiting since 2011, this project is finally in full operation with funding provided mostly by the Environmental Protection Agency (EPA). The Project is under the grant oversight of the Hopi Utility Corporation (HUC). Director Tim Bodell, has made significant strides in this Project.

The First Mesa Consolidated Villages (FMCV) Traditional Leadership provided the required approvals for rights-of-ways and Environmental Clearances early in the beginning of the (north of Polacca) to provide the water source for First and Second Mesa Villages.

Funding by the Bureau of Indian Affairs will provide HAMP water to be extended to Keams Canyon. Again, our Leadership approved the required documents to extend the pipeline to Keams Canyon. Keams Canyon is currently served by the Low Mountain Wells which has very high levels of arsenic and was cited by EPA years ago. The Low Mountain wells have an arsenic treatment plant which will no longer be in operation upon completion of HAMP. In fact, all the wells in First Mesa will be sealed off according to the EPA laws.

This week, we witnessed water pipes being delivered to the West Polacca area to be used to start the construction of the water lines north to the well fields. Two large water storage tanks will be constructed next to our present west storage tank. The current construction schedule is slated to be completed within a year, or sooner. It has been a long, hard struggle for the reality of the Project; but now that it has started, that is now in the past.

FMCV had to submit a Compliance Agreement in 2015 to be approved by the EPA due to the high arsenic levels in our water wells. This Agreement justified how and when the village water system, would be replaced with the completion of HAMP. Also, considering the opposition by Users of our current water, EPA approved the Agreement with the following Quarterly Water Test samples (very costly), Quarterly Compliance Reports and Quarterly Public Notices to consumers. (See Public Notice on Page 4). All documents are available for public inspection.

2.The First Mesa Meter Project: Construction is currently scheduled for a bid opening and soon after the Bid Opening, construction will be awarded and installation of the water meters will start.

Water customers will be billed according to water usage, similar to APS billings. The meters will be read electronically each month. Customers are advised to practice conservation.

The water will be treated at the well site by the HUC and delivered to the First Mesa storage tanks. First Mesa will pay HUC for gallons of water into the tank. Customers will be billed for the cost of the water distribution. The per gallon cost will be determined by the Utility Corporation.

Into the future, the FMCV Administration is recommending that our Traditional Leaders turn our village owned water system over to the Hopi Utility Corporation.

It has been a struggle all these years to maintain the operations with no tribal revenues to supplement the cost of operations. Cost to operate a water system is extremely costly. Water bills will be higher, but will not have the high levels of arsenic in the water, which we all want.

3. Conditions of our present Sewer Lagoon: HUC is currently assisting FMCV on improving our sewer lagoons. At the beginning of the construction of our water system, the project had budgetary short falls and the sewer lagoon was not constructed according to construction plans. A deep sewer line had to be constructed during the project in the center area of First Mesa to allow for gravity flow. This change order was very costly and eliminated some of the critical needs which we are now experiencing. The engineering was done by the Indian Health Service and inspectors for the project was also by Indian Health Service.

Three wells were drilled in the Hardrock range area HUC retained the services of a consulting agency who last week accompanied our Water Operations Supervisor Alphonso Sakeva, Jr to review the lagoon conditions. Annually, especially during the summer months, we receive complaints from home owners about sewer odors. The lagoon must have air raiders powered by electricity to treat and control the sewer water and the vegetation must be cleared to allow for proper ventilation.


> The protection fence must be repaired to keep persons out of the lagoon. There has been considerable vandalism and the raw waste water is hazardous to a person's health.

> Currently, there is no charge to water users for sewage treatment like other water services. The Hopi Health Care Center, Walpi Housing and the Hopi Dialysis Center all use our lagoon by the use of a lift station. It would be to the best interest of our village water system to construct a new lagoon. Lagoons at Low Mountain Junction and behind the First Mesa Village are needed to allow the homes to eliminate septic tanks.

> 4. Finally, the Design to pave the west road, that goes behind First Mesa, has been completed: The road rights-of-way and EA clearances were approved by our leaders years ago. This project has been on hold waiting on construction funds. Our Office was notified that it is possible this project could now be scheduled for construction. This dirt road is impassable during rainy and snowy weather.

> We extend our appreciation to Representative Wallace Youvella Jr. who is currently the Vice-Chairman of the Hopi Transportation Committee. His determined representation to advocate for the needs of the village is resulting in the possible construction of a paved road.

> This transportation project will also, now include the Polacca Airport. An update will be in our next edition.

## **Upcoming Tribal Elections** for Hopi Chairman and **Vice Chairman**

### CONSTITUTION AND BY-LAWS OF THE HOPI TRIBE **Article IV, Sec. 9**:

The Chairman and Vice Chairman shall serve for a term of four (4) years. Candidates for the offices of the Chairman and Vice Chairman

- ° Be members of the Hopi Tribe,
- ° Twenty-five years of age or older,
- ° And must speak the Hopi language.
- Each candidate for either of said offices must also have a primary and physical residency on the Hopi Reservation for not less than two years immediately preceding his announcement of such candidacy.
- ° A candidate must not have been convicted of a felony or any crime involving moral turpitude within ten (10) years of candidacy.



## **PUBLIC NOTICE Arsenic Levels exceed Federal Water Standard**

Per the Compliance Agreement signed with the EPA in 2015, the First Mesa Consolidated Village Water Program is required to provide quarterly Notices of the high arsenic level to its customers, up until the Hopi Arsenic Mitigation Project is

NOTICE: The Polacca water system recently violated the drinking water standards for arsenic. Although this is not an emergency, as one of our customers, you have the right to know what happened, what you should do, and what we are doing to correct this situation.

We routinely monitor for the presence of drinking water contaminants. Test results we received show that our system exceeds the standard or maximum contaminant level (MCL) for arsenic. The standard for arsenic is 0.010 milligrams per liter (mg/L) or 10 parts per billion (ppb). Arsenic in the Polacca water system was found at 0.016 mg/L-West-Well #5 and 0.021 mg/L East-Well #8 for the month of September 2020.

Arsenic in the drinking water can come from the erosion of natural deposits, runoff from orchards, or glass and electronic production waste.

### What should I do?

You do not need to use an alternative water supply, such as bottled water. If you have specific health concerns, please consult your health provider.

### What does this mean?

Your water is not an immediate risk. If it had been, you would have been notified immediately. Some people who drink water containing arsenic in excess of the MCL over many years could experience skin damage or problems with their circulatory system, and may have an increased risk of getting cancer.

### What is being done?

The Polacca water system will be tied into the Hopi Arsenic Mitigation Project (HAMP). The source wells for the HAMP have, and are expected to have, arsenic levels below 10ppb. Construction of the first phase of the HAMP, which will tie in the Polacca water system, is presently expected to be started in the fiscal year 2021. Once the Polacca water system is tied into HAMP, the arsenic should be resolved.

### When You've Been Fully Vaccinated

COVID 19 vaccines are effective at protecting you from getting sick. Based on what we know about COVID-19 vaccines, people who have been fully vaccinated can start to do some things that they had stopped doing because of the pandemic.

After you've been fully vaccinated against COVID-19, you should keep taking precautions in public places like wearing a mask, staying 6 feet apart from others, and avoiding crowds and poorly ventilated spaces until we know more.

#### WHAT HAS CHANGED

If you've been fully vaccinated:

- You can gather indoors with fully vaccinated people without wearing a mask.
- You can gather indoors with unvaccinated people from one other household (for example, visiting with relatives who all live together) without masks, unless any of those people or anyone they live with has an increased risk for severe illness from COVID-19.
- · If you've been around someone who has COVID-19, you do not need to stay away from others or get tested unless you have symptoms.
  - · However, if you live in a group setting (like a correctional or detention facility or group home) and are around someone who has COVID-19, you should still stay away from others for 14 days and get www.cdc.gov tested, even if you don't have symptoms. IMPORTANT CONTACT

### What Hasn't Changed

### For now, if you've been fully vaccinated:

- You should still take steps to protect yourself and others in many situations, like wearing a mask, staying at least 6 feet apart from others, and avoiding crowds and poorly ventilated spaces. Take these precautions whenever you are:
  - In public
  - Gathering with unvaccinated people or others not from your household
  - Visiting with an non-household member or who lives with a person at increased risk
- · You should still avoid medium or large-sized
- If you do travel off reservation, you'll still need to follow CDC requirements and recommendations.
- You should still watch out for symptoms of COVID-19, especially if you've been around someone who is sick. If you have symptoms of COVID-19, you should get tested and stay home and away from others.
- You will still need to follow guidance at your workplace.



# **Hopi Tribe Department of Health & Human Services COVID-19 Emergency Response Report, April 16**

KYKOTSMOVI, AZ - April 16, 2021 — Nationwide there has been a moderate increase in cases due to a combination of the more transmissible variants of the COVID-19 virus and certain states lifting their preventative guidelines. Currently the rising cases are mostly found in the Midwest and the North East. Arizona has continued to have a lower relative Covid-19 burden, but Coconino County and the Western communities of the Navajo Reservation have continued to see increases. Furthermore, the Hopi reservation continues to see small pockets of Covid-19 and is monitoring for community transmission. We all must continue to practice the three Ws, Watch your distance, Wash your hands and Wear a mask. In addition to the three Ws, everyone who can be vaccinated (people over the age of 16), should contact their healthcare provider about receiving the Covid-19 vaccine.

For the Covid-19 vaccines, overall effectiveness has been reported in the range of 70% to 95% for symptomatic Covid-19, which is well above the average effectiveness of the flu vaccine, for example. Not only do these vaccines appear to lessen risk of developing COVID-19, but they also appear to lessen the risk of severe disease. In large clinical trials, most side effects have been minor. When side effects do occur, they typically last just a few days. A side effect or reaction isn't necessarily all bad, as it may indicate that the body is building protection against the virus. Common side effects include: 1.) pain at the site of the injection; 2.) painful, swollen lymph nodes in the arm where the vaccine was injected; 3.) overall fatigue; 4.) headache. It is normal to feel apprehensive about any new treatment. But two common misconceptions often result in people avoiding the COVID vaccine unnecessarily. When health problems develop soon after vaccination, people tend to blame the vaccine. Yet cancer, strokes, heart attacks, blood disorders, and rare illnesses occurred before the pandemic, and will of course continue to happen long after. If a person contracts COVID-19 soon after vaccination, it is not due to the vaccine. No live SARS-CoV-2 virus is used in the currently available vaccines or those in development.

Here is a quick overview of the COVID-19 statistics on a national, state, and local level:

As of April 16, 2021

The United Sates now has approximately 31.3 million confirmed positive cases with 74,834new cases and over 562, 296 deaths reported.

Over 852,570 confirmed positive cases now exist in Arizona. Of those, close to 16,032 are in Navajo County alone.

The Hopi Health Care Center has tested over 9,078 patients to this date. Over 1,385 of those tests at Hopi Health Care Center came back positive with 1004 from Hopi Tribal members. Tuba City Regional Health Care Corporation reported 269 positives for Hopi Villages with a combined number of 1273 positive Hopi Tribal

This Table looks at both cases per capita for the Tribe and persons that have received at least one dose of the vaccine since the beginning of the pandemic. The village populations were calculated from the enrollment data from the Tribe and is simply a rough estimate. The most important feature of the table is the percent relative to the average for vaccination to target our implementation. It is also important to evaluate the prevalence to vaccine acceptance. This comparison demonstrates the health behavior of the village.

\*Excludes the vaccines from Keams Canyon, Spider Mound and those calculated as Second Mesa. The three groups combine for another 329 Hopi Tribal members who have received at least the first dose of the vaccine.

# FEMA providing financial Assistance for COVID-19 related Funeral Expenses incurred after Jan 20, 2020

WASHINGTON -- In early April, FEMA will begin providing financial assistance for funeral expenses incurred after Jan. 20, 2020 for deaths related to coronavirus (COVID-19) to help ease some of the financial stress and burden caused by the pandemic. The policy was finalized today, and FEMA is now moving rapidly to implement this funeral assistance program nationwide.

"At FEMA, our mission is to help people before, during and after disasters," said Acting FEMA Administrator Bob Fenton. "The COVID-19 pandemic has caused immense grief for so many people. Although we cannot change what has happened, we affirm our commitment to help with funeral and burial expenses that many families did not anticipate."

### Who can apply for COVID-19 Funeral Assistance?

You may qualify if:

- 1. You are a U.S. citizen, non-citizen national, or qualified alien who paid for funeral expenses after January 20, 2020, and
- 2. The funeral expenses were for an individual whose death in the United States, territories or the District of Columbia, may have been caused by or was likely the result of COVID-19.

### Who Cannot Apply?

- § A minor child cannot apply on behalf of an adult who is not a U.S. citizen, non-citizen national, or qualified alien.
- § There are several categories of aliens lawfully present in the U.S. who are not eligible for FEMA's Individual and Households Program assistance, including funeral assistance. These include, but are not limited to:
- ♦ Temporary tourist visa holders
- ♦ Foreign students
- ♦ Temporary work visa holders
- Habitual residents such as citizens of the Federated States of Micronesia, Palau, and the Republic of the Marshall Islands.

Call this dedicated toll-free phone number to get a COVID-19 Funeral Assistance application completed with help from FEMA's representatives. Multilingual services will be available.

### No online applications will be accepted.

When you call, it should take about 20 minutes to apply. We will not rush through calls because we intend to make sure every applicant gets their questions answered and receives the help they need to apply.

It is important to gather all necessary information and documentation before applying for assistance. This will help us take the application and process it in a timely manner.

Once you have applied and are given an application number, you may provide supporting documentation to FEMA a few ways:

- § Fax documents: 855-261-3452.
- § Mail documents: P.O. BOX 10001, Hyattsville, MD 20782

### I'm getting a busy signal. What do I do?

- § We are receiving high call volumes, which is causing some technical issues. Some applicants are reaching operators, while others are receiving a busy signal.
- § If your call was not able to connect, please try calling again later. We are working to correct the

technical issues. Keep in mind there is no deadline to apply.

#### Can a funeral home apply on behalf of the family?

Funeral homes are not eligible to apply on behalf of a family or to be a co-applicant on the Funeral Assistance application. The person applying must be an individual, not a business, who incurred the funeral expenses.

#### What funeral expenses are covered?

COVID-19 Funeral Assistance will assist with expenses for funeral services and interment or cremation. Any receipts received for expenses that are not related to funeral services will not be determined eligible expenses. Expenses for funeral services and interment or cremation typically include, but are not limited to:

- § Transportation for up to two individuals to identify the deceased individual
- § Transfer of remains
- § Casket or urn
- § Burial plot or cremation niche
- § Marker or headstone
- § Clergy or officiant services
- § Arrangement of the funeral ceremony
- § Use of funeral home equipment or staff
- § Cremation or interment costs
- § Costs associated with producing and certifying multiple death certificates
- § Additional expenses mandated by any applicable local or state government laws or ordinances

#### I was responsible for funeral expenses for more than one person whose death was attributed to COVID-19. Can I apply for COVID-19 Funeral Assistance for more than one death? Is there a limit?

Yes, applicants may receive assistance for the funeral expenses of multiple deceased individuals.

Assistance is limited to a maximum of \$9,000 per funeral and a maximum of \$35,500 per application per state, territory, or the District of Columbia.

### Someone else helped me pay for funeral expenses. Can they apply for COVID-19 Funeral Assistance?

FEMA will generally only provide COVID-19 Funeral Assistance to one applicant per deceased individual.

To be approved for reimbursement of funeral expenses due to a COVID-19 fatality, you must have incurred funeral expenses for the deceased individual and have documentation (receipts, funeral home contracts, etc.) showing your name as the responsible party.

We recognize that multiple individuals may have contributed to funeral expenses for one deceased individual. FEMA will work with applicants in these situations and those who submit multiple receipts for funeral expenses when their name does not appear on the receipt.

If more than one individual contributed toward funeral expenses, they must register with FEMA under the same application as the applicant and coapplicant, or the first applicant that submits all required documentation will be awarded COVID-19 Funeral Assistance for the deceased individual. No more than one co-applicant can be included on an application.

If a minor child directly incurred funeral expenses for a COVID-19-related death and the documentation supports that payment, the minor child's application could be reviewed for COVID-19 Funeral Assistance.

# Can I apply for COVID-19 Funeral Assistance even though I've already applied for a recent disaster event?

Yes. Applicants who recently applied for FEMA assistance for home and/or personal property damage from a disaster and also had funeral expenses

for a death attributed to COVID-19 after January 20, 2020, may apply for COVID-19 Funeral Assistance. A separate application will be required.

# Are pre-planned and pre-paid funerals eligible for reimbursement if the individual died due to COVID-19?

Any source of payment designated specifically to pay for a funeral in anticipation of a future death cannot be reimbursed under this assistance. This includes burial or funeral insurance, a pre-paid funeral contract, a pre-paid trust for funeral expenses, or an irrevocable trust for Medicare.

### What is the deadline to apply for COVID-19 Funeral Assistance?

At this time, there is no deadline to apply for COVID-19 Funeral Assistance. FEMA will communicate a specific deadline once established.

#### Will the money run out?

Passing of the American Rescue Plan Act of 2021 now makes it possible for families and individuals who incur funeral expenses due to COVID-19 in 2021 and beyond the ability to apply for Funeral Assistance. Since there is no way to predict how many COVID-related deaths may occur between now and 2025, an exact funding cap has not been established.

### AFTER RECEIVING A DECISION

#### **How will I receive COVID-19 Funeral Assistance?**

If you are approved for COVID-19 Funeral Assistance, you will receive a check by mail or funds by direct deposit, depending on which option you chose when applying for assistance.

#### I received a decision letter and was not approved. How do I appeal FEMA's decision?

You have 60 days from the date of the decision letter to upload, fax or mail a signed letter appealing FEMA's decision.

The appeal should include the following:

- § Why you think the decision is not correct.
  - °Supporting documentation (i.e., death certificate, funeral expenses, or other supporting documentation).
- °The application number must be included on each page of the appeal submitted.
- °Appeal documents may be submitted by:
- § Upload through our Disaster Assistance.gov account.

### The death certificate doesn't attribute the death to COVID-19. How do I get a death certificate amended?

It is possible to change or amend a death certificate. This process starts with contacting the person who certified the death. This may be a treating doctor, a coroner or a medical examiner, and their name and address is on the death certificate. Applicants may present evidence to them to support the claim the death was attributable to COVID-19.

### How do I prove my loved one who died did not have life insurance?

Applicants will not be asked to provide proof of life insurance. Life insurance proceeds are not considered a duplication of Funeral Assistance benefits. However, expenses paid for with burial/funeral insurance, or a pre-paid funeral, are considered a duplication of benefits and therefore, are not eligible for reimbursement under this program.

### MENTAL HEALTH

The COVID-19 pandemic has brought overwhelming grief to many families.

### **BIE Implementation of American Rescue Plan Funding**

The \$1.9 trillion American Rescue Plan provides another round of coronavirus relief funds for Education. Congress has provided schools across the United States nearly \$200 billion in COVID-19 relief in this past year making this the third pandemic federal aid package for K-12 education.

Of the \$850 million in American Rescue Plan funding, BIE plans to allocate the funding as follows:

- \$85 million (10%) will be managed by BIE School Operations for investments such as the buildout of a Learning Management System and ventilation improvement projects.
- Of the remaining \$765 million, the distributions are as follows:
- 70% or \$535.5 million will be allocated to K-12 schools based on the Weighted Student Unit formula
- 30% or \$229.5 million will be allocated to Tribally Colleges and Universities based on student count.

BIE is currently awarding funds to schools and TCUs. TIMELINE: BIE Funding Allocations for ARP \$850 Million:

- Currently completed: funding allocations to K-12 Bureau-operated schools.
- Plan for April 25th completion: funding allocations for K-12 TCS; grant specialists entering grant documents for school drawdown.
- Plan for April 23rd completion: TCU agreements are in process

ALLOWABLE COSTS: BIE is using the same set of allowable costs identified by the Department of Education for CARES Act funding, the categories are:

- (1) Coordination of preparedness and response efforts of local educational agencies with State, local, Tribal, and territorial public health departments, and other relevant agencies, to improve coordinated responses among such entities to prevent, prepare for, and respond to coronavirus.
- (2) Providing principals and others school leaders with the resources necessary to address the needs of their individual schools.

- (3) Activities to address the unique needs of low-income children or students, children with disabilities, English learners, racial and ethnic minorities, students experiencing homelessness, and foster care youth, including how outreach and service delivery will meet the needs of each population.
- (4) Developing and implementing procedures and systems to improve the preparedness and response efforts of local educational agencies.
- (5) Training and professional development for staff of the local educational agency on sanitation and minimizing the spread of infectious diseases.
- (6) Purchasing supplies to sanitize and clean the facilities of a local educational agency, including buildings operated by such agency.
- (7) Planning for and coordinating during long-term closures, including for how to provide *meals* to eligible students, how to *provide technology for online learning* to all students, how to provide guidance for carrying out requirements under *the Individuals with Disabilities Education Act* (20 U.S.C. 1401 et seq.) and how to ensure *other educational services can continue* to be provided consistent with all Federal, State, and local requirements.
- (8) Purchasing educational technology (including hardware, software, and connectivity) for students who are served by the local educational agency that aids in regular and substantive educational interaction between students and their classroom instructors, including low-income students and students with disabilities, which may include assistive technology or adaptive equipment.
- (9) Providing mental health services and supports.
- (10) Planning and implementing activities related to summer learning and supplemental afterschool programs, including providing classroom instruction or online learning during the summer months and addressing the needs of low-income students, students with disabilities, English learners, migrant students, students experiencing homelessness, and children in foster care
- (11) Other activities that are necessary to maintain the operation of and continuity of services in local educational agencies and continuing to employ existing staff of the local educational agency
