

#### **EDUCATION**

The Tribal Council approved Action Item #062-2021 which was presented by Dr. Darold Joseph, Chairman, of the Hopi School System Transition Team. The objective of this effort was to request that the Tribal Council approve the appointment of a one-time interim Hopi Board of Education.

The background to this action item is; the Transition Team has not been successful to recruit individuals to file application to be come candidates to the Board of Education.

#### HOPI HOUSING AUTHORITY

Resolution HTHA-020-2021 Approving Hopi Housing Authority Sanitation Equipment Program Policy for Non Low-Income Families was approved. The program activity provides funding for COVID-19 Prevention, Sanitation Equipment for Non-Low Median Income Families. To assist residents of Hopi Villages to purchase sanitation equipment, wash stations, porta john and portable showers that do not have necessities and are without running water, to help mitigate the spread of COVID-19.

Resolution HTHA-021-2021 to Accept and Approve to Administer the 2021 BIA-HIP ARPA Funds by Hopi Housing Authority was also approved. This action allows the HTHA to apply for, negotiate and contract with the BIA to administer the Home Improvement Program in the amount of \$421,557.

**FMCV** Tribal Council Representatives and the Village Administrator are required to make monthly reports and updates to the First mesa Community. # FMCV Intent to Apply for Grant Funding to **Complete Critical Needs Projects**

rection and approval of the Kikmongwi Store, Laundromat, and approximately 30 and Religious Leaders, the First Mesa Consolidated Villages applied for various federal grants; however, did not receive a Hopi Tribal Council Resolutions, a requirement of the application process.

As a result, the grant applications were considered incomplete by the funding agency, due to no tribal Resolution. It is the writer's opinion that it is not the staff of FMCV who lost the opportunity for successful grants, but the people for which the grant was submitted.

At a Hopi Tribal Council meeting on Oct. 6, Chairman Nuvangyaoma advocated on behalf of allocating \$500,000 of insurance payments made to the Hopi Tribe to be given to the Hopi Tribal Economic Development Corporation for development of the former YA Hat factory at the Winslow property; yet, our reservation remains without any economic development.

There are currently no business development plans by the Hopi Tribal Administration although faced with a loss of 80% of our annual revenue.

Since the 1980's, First Mesa was supported by the Water/Corn Clan Leaders to allocate over 100 acres for development. This development site was offered to former Chairman Wayne Taylor at the time his administration was purchasing property off the reservation using the federal relocation accommodation agreement funds.

This site still remains and is identified as a prime site along State Highway 264 and has the required infrastructure for immediate development.

Several years ago, this same site was identified for a Community Development Grant within the authority of the Hopi Tribal Housing Authority. This grant was to construct a Community Building, Fire

In the past several years, and at the di-Station, Child Care Center, Convenience rental apartments. A group of village members convinced the Hopi Housing Commissioners to disapprove the federal grant application. This proposal and design drawings are still available for viewing at the FMCV office.

> The most recent application, two years ago to the Hopi Housing Authority was for housing units for the elderly and victims of COVID-19. The Housing Board of Commissioners approved this grant but the Board Chairwoman did not produce the approved resolution and the grant approval was lost.

> The FMCV regrouped recently and have again identified critical need projects in light of the continuing threat of the Pandemic. These projects are: (1) Fiber Optic Lines to increase bandwidth, (2) Improve main Sewer Lagoon, (3) three smaller Sewer Lagoons for Health Care and Walpi Housing, Low Mountain Junction Housing and behind Walpi Village, (4) Airport renovation, (5) Village WIFI signal, (6) Water Program equipment, (7) Laundromat/ Grocery/Gas Station, (8) Fast foods, (9) Post Office, (10) Child and Elderly Care Center, (11) Fire and EMS Station, (11) Warehouse, (12) Housing units, (13) Mobile RV Park, (14) Cultural Center with food, museum and tour office. These Projects are currently in discussions.

> We have retained a consultant to complete the applications for funding. We ask our village members to provide your recommendations on the listed projects, these projects are not listed in priority but will be based on funding availability. The recent Federal Rescue Plans identify Broadband and Water and Sewer as priority. Providing the best broadband connections to our schools, students and community is a must and, therefore, a priority.

# **CITIZEN PARTICIPATION REQUEST** COMMENTS ON CONSTRUCTION OF HOMES

The proposed Indian Community Development Block Grant (ICDBG) funding is for construction of ten 2-bedroom homes as a place to treat COVID-19 infected people away from their traditional homes with multi-family members and not to spread the infection to other family members.

The First Mesa Consolidated Village (FMCV) strategic plan is in prevention and protection of coronavirus pandemic to construct ten homes to isolated coronavirus infected persons in a self-quarantine home that are not available. The FMCV is seeking \$2 million for the construction to complete infrastructure and construction costs for the community protective housing.


FMCV's goal is to meet the essential needs, critical to the COVID-19 crisis, with provision of basic human protective services by providing homes to infected member in quarantine to move from overcrowded housing.

Older adults and people who have certain underlying medical conditions are at increased risk of severe illness from COVID-19. Orderly development, and stability of the community through the provision of accessibility to health and wellness resources that are central to the viability of the Hopi community. The small homes are the most critical outstanding needs confronting the Hopi community. The Hopi population has a high rate of diabetes, obesity, and other cardiovascular diseases; the tribal members' engagement in health-related preventative measures is critical in attaining community viability due to COVID-19. The homes are need for protective measures, as most villages homes have overcrowding with several generations of families living and no other place to live.

Due to COVID-19, it is not possible to do an in-person citizens meeting. As a result, the information of building ten protective homes in First Mesa for the Hopi community is being provided by newspaper publication via the Village Crier and telephone calls. Comments may be submitted by calling (928) 737-2670 or by US mail at First Mesa Consolidated Villages, PO Box 260, Polacca, AZ 86042. Please provide the following and any other information that is important to you:

# First Mesa Elementary School **October 2021 Updates**

#### Greetings from First Mesa Elementary School!

FMES recognized Sept. 20-24 as Indian week. Each day was a special day of cultural learning for the students. Monday was clan day with students wearing clothing showing their clan. Tuesday - moccasin day. Wednesday - jewelry day. Thursday - belt day. Friday - Indian Day to dress up in traditional or contemporary Indian clothes.

Indian day began with songs by the school men employees to welcome the day and students. It was a beautiful morning outdoors to hear encouraging songs and the birds. Afterwards was an entertaining and multi-cultural learning program that ended with a traditional Hopi meal. All the students went home with a happy stomach.

FMES hired three (3) Student Health Aide Screener/Bus Monitors who are Aleesha Begay, Kateri Lalo, and Lorisse Saufkie. Each Health Aide Monitor is assigned to a bus to assist each Bus Driver by conducting a health check of each student before boarding the bus. The Monitor will do a temperature check and update each student's health condition. A student with a fever is not allowed to board the bus. Health checks are conducted of all students and employees to ensure the safety of everyone.

The school was able to obtain BIA fund-

ing to upgrade its heating and cooling units. A contractor, Gilbert & Sons, was hired to install large cooling and heating units on the building's west wing in September. The upper grade classes moved to another part of the school to avoid disruption during the installation. Later this year additional heating and cooling units will be installed in the administration section of the school building.

October 13 and 14 will be Parent-Teacher conference days. Parents and guardians, please look out for a scheduled time to meet with your child's teacher. Teachers will share student's accomplishments since the beginning of the school year. They will also inform the parent if a student needs extra help at home with a certain school subject.

Wednesday, October 20, will be In-Service day for the teaching staff at the school. It will be a half day for students who will go home after lunch. The teachers will then enter the training session to enhance their teaching skills.

A few positions remain open to be filled. Special Education Teacher, School Counselor, Hopi Lavayi/Culture Teacher, Teacher Assistants, and Custodian/ Grounds Keeper. If you are interested please call the school at (928) 737-2581.

#### Ready to Help Prevent Bullying? Bullying Prevention Tip #3: Here are Ways You Can STOMP Out Stand Up to The Bully. **Bullying!**

Bullying is something many of us face, and wrong. It's not cool and they should stop. it can be difficult to know what to do. You Keep it simple. must always remember that bullying is NOT your fault. This Bullying Prevention emotionally bullies you, look them in the Tip Sheet outlines steps you can take to eye and say STOP IT NOW." And then help prevent bullying in your school or community.

#### **Bullying Prevention Tip #1:**

Report It. Don't be afraid to tell an adult. Telling isn't tattling! You are helping someone.

Prevention is best addressed by communicating and teaching the expected prosocial behaviors:

· Clearly communicate policy and protocols for bullying behaviors to all staff, students and parents

· Empower bystanders to promote and take responsibility for creating a safe and welcoming environment.

Who should you tell?

You could tell your parents, teacher, school counselor, school nurse, coach or any adult you trust.

Be sure to tell exactly what happened ... who was bullied, who the bully was, where and when it happened.

Even if you only suspect a kid is being bullied, it's a good idea to report that, too.

Most adults really do care about bullying and will be glad that you told them about it so they can prevent it from occurring in the future.

If you tell an adult and you don't think they are doing anything about the bullying or if the situation isn't improving, tell another adult. Keep telling adults until someone does something to help.

#### **Bullying Prevention Tip #2:**

Be a Friend to Someone Who Is Being Bullied When someone is down they need a

friend. Be there for the person who is being bullied. Be a buddy on school grounds, get together after school, include them in activities, walk home with them, or sit with them on the bus.

Being an understanding and supportive friend means so much. Show a kid who is being bullied that you care about them.

If you feel safe and comfortable, tell the bully that what they are doing is mean and

For example, if someone verbally or walk away. Even if they are bullying you as you walk away – keep walking.

Do not bully them back. If you are not comfortable standing up, tell an adult.

#### **Bullying Prevention Tip #4:**

If You are Left Out of A Group and Being Bullied

Very often someone you thought was your friend, has joined the bully's side. While this does hurt you, ask yourself ... how much of a friend could they have really been if they're doing this to you? Find other friends, join groups and clubs at school. The best revenge is to be happy!

#### **REMEMBER:**

• It's NOT your fault. No one deserves to be bullied!

• Don't fight back or bully a person back. It won't make things any better and it will probably get you into trouble. The ONLY time to fight back is if someone is physically hurting you. At the same time others who see this should seek help from a trusted adult.

 Never keep the pain of being bullied to yourself. Tell someone. Tell a friend. Tell a trusted adult. Report it! Telling is Not tattling.

• Don't skip school or avoid friends, sports or clubs because you're afraid of the bully. You have a right to be there just as much as the bully does.

 No matter how bad you feel, hurting yourself or thinking about suicide is NOT the answer. Nothing is that bad. Talk with an adult and get help.

Does your school have a peer mentoring group? If so, talk to them. Ask for help. ids who are not bullying victims can help too.

Ask your principal if you can start a peer mentoring group. You and your group can focus on bullying prevention and start a bully-free community in school.

Before you know it the only lonely ones will be the bullies who will surely want to change their behavior when they're left out.



To the Hopi Tribal Council and those listed above;

I am Emil Honie, SR., the SAND CLAN LEADER of the Tewa Village. I have sole authority to speak for my People and have the sole authority in the matters of land and ceremonial events to take place for the Sand Clan members.

It is I who donated 55 acres to the Village of Tewa Administration for the use of and for the People, but to be run in a safe and orderly way by the CSA and workers.

I give my whole support to the elected Board of Directors that are seated by the People and not to the few who don't speak for All of the People

They have rules and ways to go about getting people out of there who aren't doing what we, the Clan Leaders, through the Board of Directors and to the CD workers, tell them to do for our People. That was not done properly and I do not recognize the illegal board that put themselves in there without the more than half of the Tewa People to say their part.

The Clan Leaders from the Stick/Spider and Kachina/Parrot Clans, don't recognize them in any way too and its mostly their own people who are doing this bad thing to all the Tewa People

Due to them hurting the Tewa people, I am ordering the entire 55 acres and the Tewa CD to be shut down immediately until I say when it opens back up. I am doing this to be Fair to the workers and the CSA who is getting blamed for these things but we told her to take the work they put into helping the Tewa people so nobody will tamper with the work. They know what they are doing and we will let them do their audit work and then they can quit working for the Tewa people after that if they want to because of all the bad things that a few Tewas are doing for themselves. We don't want them to get hurt because the police won't help them when they get death things sent to them. This is the my words for what is happening and the Tewa CD is shut down after my signature is penned.



The Hopi Health Care Centers most recent data report indicates over 11,261 patients tested as of October 6, 2021. Over 1,512 of those tests at Hopi Health Care Center came back positive with 1101 from Hopi Tribal members. Tuba City Regional Health Care Corporation reported 302 positives for Hopi Villages with a combined number of 1,416\*\*\* positive Hopi Tribal members.

As of October 7, 2021 the United States now has approximately 43,773 million confirmed positive cases with over 702,630 deaths reported and over 1,106 million confirmed positive cases now exist in Arizona. Of those, close to 19,941 are in Navajo and 21,694 in Coconino Counties.
